## IV. Presentation

Councilwoman Jenny Mundell read the following aloud for National Gun Violence Survivors Week:

### **NATIONAL GUN VIOLENCE SURVIVORS WEEK FEBRUARY 1- FEBRUARY 8, 2020**

**WHEREAS**, every day, 100 Americans are killed by gun violence and on average there are nearly 13,000 gun homicides every year; and

**WHEREAS**, every year, over 36,000 Americans are killed in acts of gun violence and 73,000 more are shot and wounded;

**WHEREAS**, by early February, more Americans are killed with guns than are killed in our peer countries in an entire calendar year;

**WHEREAS**, a gun violence survivor is anyone who has personally experienced gun violence - whether you have witnessed an act of gun violence, been threatened or wounded with a gun, or had someone you know and cared for wounded or killed;

**WHEREAS**, forms of gun violence can include, but are not limited to: gun suicides, gun homicides, domestic violence involving a gun, shootings by law enforcement, and unintentional shootings;

**WHEREAS**, 58 percent of American adults or someone they care for has experienced gun violence in their lifetime, demonstrating the reach and impact gun violence has in communities across America;

**WHEREAS**, firearms are the second leading cause of death for children and teens and the first leading cause of death for Black children and teens in America;

**WHEREAS**, Americans in cities across the nation are working to end the senseless violence by advocating for common-sense gun safety legislation;

**WHEREAS**, by commemorating National Gun Violence Survivors Week on February 1 to February 8, cities across America will raise awareness about gun violence and honor the lives stolen by gun violence; and

**WHEREAS**, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands and encourage responsible gun ownership to help keep our communities safe.

**NOW, THEREFORE BE IT RESOLVED, I MICHAEL J. VENEZIA**, as Mayor of the Township of Bloomfield, along with the Township Council, do hereby declare the first February 1- February 8, 2020 to be National Gun Violence Survivors Week to honor and remember all victims and survivors of gun violence. We encourage all citizens to uplift the resilient voices of survivors across the nation and support their communities' efforts to prevent the tragic effects of gun violence.

Ollyn J. Lettman, director of the Bloomfield Center Alliance, took to the microphone to present the finalized 2020 BCA budget. Mr. Lettman presented an outline of the accomplishments, events and activities the BCA had last year to the council such as Dinner under the Stars, the Harvest Fest and Small Business Saturday. Mr. Lettman talked about the BCA's growing Facebook page and their façade grant program, which provided capital and incentive for local business owners to obtain a new awning or lighting. He also gave the Council a comparative analysis of the 2019 budget and the proposed 2020 budget as well as a preview of some events the BCA would like to sponsor this year. Councilwoman Mundell and Mayor Venezia asked for more details about the strategic plans for Bloomfield and Councilman Gamble discussed the BCA's marketing budget. Mayor Venezia talked about the importance of the BCA to have a plan for new and existing businesses and how the governing body can work with them and help. Councilwoman Davis stressed the importance of community input to help the BCA with their plans.

**3. PSE&G Transmission Line Upgrade**

Joe McQueen from PSE&G talked about the growth within the Township of Bloomfield and how in order to manage that some of the existing pole lines should be replaced to meet some of the demands the stations are realizing. He also explained how they plan to inform residents about the upcoming work and how PSE&G will coordinate with the Police Department. He projected that the work would be completed in about three years. Mayor Venezia asked about the radius of notification to residents in the impacted area, which would be along Washington Street near the train tracks. Mr. McQueen detailed how they plan to notify these residents and when they would begin/end their work so they would not negatively impact traffic during this time period. Councilwoman Mundell also recommended that they notify cross streets as well. Councilman Joanow asked that light repairs be moved to the forefront of the short list to be fixed. Mr. McQueen said he would provide a projected timetable and list for the Council.

**V. Public Comment**

J. Andrew Smith, Bloomfield, New Jersey, took to the microphone to discuss an incident on the prior Thursday in which a school bus went through the intersection of East Passaic and Coeyman almost hitting a crossing guard, student and a SUV making a turn. The school bus swerved and narrowly missed everyone. Mr. Smith wanted to bring this to the attention of the Mayor and Council because he said things happen like this all the time at bus stops. He suggested that crossing guards should have body cameras.. Mayor Venezia said the police department would look into it and see if they could devise a solution.

David Cummings, of the Montclair Neighborhood Development Corporation, discussed the organization and how they can help Bloomfield residents. He planned to meet with the guidance counselors at the High School on how to teach students about career development. Mayor Venezia said he would like to set up a meeting at a later date to talk more about the organization and how they plan to help the residents.

Maria Probst, Bloomfield, New Jersey, took to the microphone to talk about the reval letters and wanted to know more about appointments. Mayor Venezia and Township Administrator Matt Watkins provided more details about the time and how long until residents can file an appeal.

Norm Sutaria, Bloomfield, New Jersey, asked about the online appointments for the assessments. Mr. Suttera also discussed pedestrian safety in town and said some kind of committee should be established and now is a critical time to do so because Bloomfield is growing. He also talked about his support for body cams for crossing guards and wanted to know if Bloomfield could mirror Montclair's Pedestrian Safety Committee. Mayor Venezia said they would look into this committee.

**VI. TOWNSHIP ADMINISTRATOR:****1. Request to Rezone Properties Surrounding 113 Washington St. Block 224 Lots 7,9, 10, 11 to M1 Zone**

Township Administrator Matt Watkins said there is a request by PSE&G about the above properties to rezone them to a M1 Zone while the PSE&G project takes place. This Ordinance would be introduced with a resolution that would send it to the Planning Board for consideration and recommendation before the Ordinance goes to Second reading. Planning Director Bonnie Flynn would prepare the recommendation.

## 2. Discussion of Short Term Lease Alternatives

Township Administrator Matt Watkins talked about the growing trend in town of Short Term Rental properties. Mr. Watkins said at the moment there is no regulation for this and residents have expressed concern. Mr. Watkins said Township Attorney Michael Parlavecchio put together an ordinance that would restrict some of the short term rentals in the township. Mr. Parlavecchio said that some of the issues concern residential zoning, safety and health. Bloomfield surveyed other towns to see what they had in place and it seemed that short term rental ordinances restricted people from renting their properties for less than 30 days. However, it doesn't restrict month to month renting for those coming off a one year or six month lease. These ordinances also restrict advertising for the short term rentals.

**XII. TOWNSHIP COUNCIL****1. Liaison Reports**

Councilwoman Davis talked about the results of the Civil Rights Commission's Essay Contest. There were 176 submissions which was a significant uptick. Councilman Joanow provided an update from the Recycling Committee. He urges residents not to use plastic bags when recycling and also cautioned against cross contamination when recycling products.

Councilman Rockwell talked about the next hike on May 2, for the Morris Canal Greenway Committee which will be on a new trail. Councilman Rockwell also said there will be another Scout project focusing on that trail on March 7. He also talked about the survey from the Historic Preservation Committee as well as some ordinances from the Planning Board which he has recommendations to make to improve them.

**Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations or possible violations of the law;**

**Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer;**

**Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting;**

**Any deliberation of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party as a result of an act of omission for which the responding party bears responsibility;**

**Any matter involving the employment, appointment, termination of employment, disciplinary action unless individual in writing requests a public meeting;**

**Any deliberations of the public body occurring after a public hearing that may result in the imposition of specific civil penalty.**

#### **XIV. Adjournment**

The Council did not return from Closed Session and the meeting was adjourned at 9:13 P.M.
