

**MINUTES FOR BLOOMFIELD TOWNSHIP COMBINED CONFERENCE/REGULAR MEETING**

**Monday, July 27, 2020**

**6:30 PM – Council Chambers, 1 Municipal Plaza, 2nd Floor, Municipal Building**

**I. Call to Order**

With the absence of Mayor Michael Venezia, Municipal Clerk Louise Palagano read the Sunshine Compliance Statement.

**II. Public Comments**

**III. Township Administrator**

**1. Discussion of Food Truck ORD**

Township Administrator Matt Watkins explained how Councilwoman Cruz asked him to look into the current Food Truck Ordinance. Matt then explained the current four tiers of licenses and how many are awarded per tier. Matt also said the current ordinance needs improvement. He would like to put together a matrix proposal for the Council and go from there. Councilwoman Mundell asked a few questions including how other towns have handled this ordinance and the fees. She also asked that in the new Ordinance that there is a provision put in place that wouldn't allow these food trucks to be by schools during certain hours. Matt also discussed a possible bid process for the food trucks. Councilman Gamble asked that in the new application the food truck owners should include where they plan to have the truck and Councilman Joanow discussed possible limitations set forth by the permit. Matt said he and Township Attorney Michael Parlavecchio would continue to look into the Ordinance and present a draft to the Council.

**VIII. Township Council**

**1. Update on Community Conversations - Davis, Mundell**

Councilwoman Wartyna Davis and Councilwoman Jenny Mundell gave an update on the ongoing virtual community conversations being held. Councilwoman Davis said the conversations have brought together more voices from the community about important topics such as race and the police department and race and health care. The Council would like to continue these conversations and encouraged the public to contact them if they have any further ideas.

**2. Review of zoning for pool permits – Venezia**

Township Administrator Matt Watkins explained that the topic of zoning for pool permits will be tabled until August.

**3. Farmers Market – Mundell**

Councilwoman Jenny Mundell explained that residents are interested in a Farmers Market. There has been a proposal for a “grab and go” during the pandemic to help residents experiencing food insecurity. Township Administrator Matt Watkins said the Township is looking into setting up this type of Farmers Market for October/November ending right before the Mayor’s Annual Turkey giveaway. Ideally, the township would also like to have a Farmers Market in the spring as well.

**4. Food Pantry Update – Mundell**

Councilwoman Mundell explained that due to the pandemic some residents have been experiencing food insecurity. Paula Peikes of the Health and Human Services Department then joined the meeting to explain how the Township has responded. She listed the various food pantries, food drives and neighboring food programs that the Township has participated in to make food available to those who need it. Lastly, she talked about the various donations/grants the Township received to distribute food.

**5. Parks, Recreation, and Cultural Affairs Committee appointment – Mundell**

Due to a resignation, there is a vacant position on the Parks, Recreation, and Cultural Affairs Committee appointment. Councilwoman Jenny Mundell recommended Maria Estrela to assume the role. The recommendation was approved for the adoption of the appropriate Resolution. Vote showed the following:

Councilwoman Sarah Cruz asked Acting Mayor Davis if she could add one more addition to the agenda. Davis agreed. Councilwoman Cruz asked Township Attorney Matt Watkins whether the Township could increase the business improvement district to go beyond Watsessing Avenue to North 15<sup>th</sup> Street. She asked for help from the Township in cleaning up the litter/debris in that area. Matt said he would start to work on that and have the DPW in that area.

**5. Liaison Reports**

Councilman Richard Rockwell provided an updated from the Morris Canal Greenway Committee. Scout Troop 22 held a service project regarding Native Plant Restoration. The troop removed 2,500 invasive plants and the project is ongoing. Councilman Rockwell also gave an update from the Historic Preservation Committee. They plan to send out a survey to the town to look at historic areas outside the current area.

Councilman Nick Joanow talked about the Shredding Event which will be held in Pulaski Park parking lot on August 1, 2020 from 9 a.m. to 12 noon. The event is open to Bloomfield residents and ID is required. Another shredding event is planned for November. Councilman Joanow also provided an update on the Food Waste Bill signed by Gov. Phil Murphy and how it will impact the Recycling Committee and Environmental Commission. The bill will create a process to recycle food wastes and he will circulate the bill to the Council. Lastly, Councilman Nick Joanow talked about the importance of the ongoing Census and urged residents to complete their forms.

Councilwoman Mundell shared an update on the Parks, Recreation and Cultural Commission’s summer programs as well as their final drive-in move event of the summer which will be held on July 28. She also shared information on a few of the August events such as the Cruise Nights, Golf Outings and Special Needs Summer Camp. Councilwoman Mundell also mentioned that curbside pickup is still available at the Library and they are continuing their virtual summer reading program. Lastly she talked about the expanded WiFi from the Library to the Town Green.

Acting Mayor Davis shared with everyone that former Councilman and BCA member Tim Kane passed away. She also provided an update on the strategic planning of events for the remainder of the summer and fall including Dinner Under the Stars and Cruise Nights.

**WHEREAS**, pursuant to N.J.S.A. 40:67-2, in pertinent part, a copy of any ordinance accepting the dedication of any street or portion thereof, with a map showing the location, bounds and dimensions thereof, shall be filed in the office where the conveyance of lands are recorded in the county in which the municipality is situated; and

**WHEREAS**, pursuant to N.J.S.A. 40A:12-5(a)(1) in pertinent part, any municipality, by ordinance, may provide for the acquisition of any real property by purchase, gift, devise, lease, exchange, condemnation or installment purchase agreement; and]

**WHEREAS**, 19 Ward Street Associates, LLC (“Grantor”) wishes to dedicate to the Township for roadway purposes a portion of its property along Ward Street located on Block 225, Lot 1 of the official tax maps of the Township, as further set forth in Exhibit A herein and made a part hereof (the “Dedication Parcel”); and

**WHEREAS**, the Township wishes to accept the right-of-way Deed of Dedication of the Dedication Parcel subject to review and approval of the right-of-way dedication by the Township Engineer.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP THAT:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Subject to the review and approval by the Township Engineer, the Township accepts the dedication of the portion of Block 225, Lot 1 as further set forth in Exhibit A, including all utilities and improvements installed therein, as part of the public road system of the Township of Bloomfield.

Section 3. The Township Engineer is authorized to inspect the subject roadway and to determine whether the roadway is constructed in conformance with all applicable Township regulations.

Section 4. The Mayor and Township Clerk are hereby authorized to execute and deliver any document, and together with the Township’s officials and consultants, to take any and all necessary steps as would be reasonable or necessary to effectuate said acceptance and to effectuate the purposes of this Ordinance.

**ORDINANCE AMENDING CHAPTER 315, ARTICLE V. ZONING, § 315-34 “ESTABLISHMENT OF ZONES” OF THE TOWNSHIP OF BLOOMFIELD CODE, REVISING THE ZONING MAP TO PLACE BLOCK 224, LOTS 7, 9, 10 AND 11 IN THE M-1 ZONE**

**WHEREAS**, Chapter 315, Article V. Zoning, § 315-34 “Establishment of Zones”, of the Township of Bloomfield Code (**the “Code”**) acknowledged in §315-34(B) that the Zoning Map of the Township of Bloomfield was adopted on July 25, 2005, and that the Map depicts the location and boundaries of the 17 zones, two overlay districts and the designated redevelopment areas within the territory of the Township of Bloomfield (**the “Township”**); and

**WHEREAS**, following a reexamination of the Township Master Plan, the Township adopted an amended Zoning Map on October 6, 2014; and

**WHEREAS**, §315-34 (A) (15) of the Code established the M-1 Zone - General Industrial (**“M-1 Zone”**) within the Township, which is reflected on the 2014 Zoning Map; and

**WHEREAS**, §315-38 (K) of the Code sets forth the intent of the M-1 Zone is to establish areas within which industrial uses may be established and expanded under suitable controls; and

**WHEREAS**, PSE&G operates their Toney’s Brook Substation located at Block 224 Lot 11 in the Township’s PI or Private Institutional Zone; and

**WHEREAS**, PSE&G has advised the Township of its needs to upgrade and expand their facility due to increased usage and safeguarding from future flood events. The substation was originally built in 1965 with no significant work or upgrade to the site since then; and

**WHEREAS**, the Township has been made aware that PSE&G is under contract to purchase Lots 7, 9 and 10 for the purpose of upgrading the Toney's Brook Substation on Lot 11, with the four lots totaling 1.32 acres; and

**WHEREAS**, PSE&G has requested the Township review its land use standards; and

**WHEREAS**, Lots 7, 9 and 10 are in the R1B Zone and contain existing non-conforming uses, with Lots 7 and 9 consisting of mixed-use buildings with two dwelling units each and Lot 10 consisting of a two dwelling unit home; and

**WHEREAS**, Lot 11 is in the PI Zone, which does permit public utilities, but the bulk standards of the zone render the property non-conforming; and

**WHEREAS**, the M-1 Zone is considered the general industrial zone and includes public utilities as a permitted use along with other non-industrial uses; and

**WHEREAS**, the bulk standards of the M-1 Zone more closely match the smaller scale of the area, as the M-1 Zone has a minimum lot area of 1 acre versus the P1 Zone minimum lot area of 10 acres; and

**WHEREAS**, the M-1 Zone includes public utilities as a permitted use and the bulk standards would enable any future expansion without the need for variances; and

**WHEREAS**, it is recommended that the triangular-shaped area (Block 224, Lots 7, 9, 10 and 11) should be rezoned to M-1 to recognize the existing non-conformity and the expansion/upgrade of the PSE&G Toney's Brook Substation located on Lot 11; and

**WHEREAS**, pursuant to N.J.S.A. 40:55D-26 and the Municipal Land Use Law ("MLUL"), all ordinances constituting a development regulation must be referred to the Planning Board for review to determine whether there are any inconsistencies between the proposed ordinance and the Township Master Plan and for any other recommendations the Board may deem necessary.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey as follows:

2. During said catastrophic leave of absence, employee shall continue to be covered for pension, health benefits, dental plan and prescription drug plan and life insurance in accordance with the terms and conditions of the agreement identified in paragraph 1 above.
3. During said catastrophic leave of absence, if employee engages in any other gainful employment, his leave with the Township shall be automatically terminated.
4. Prior to their return to work the employee must submit a note from their Physician, who must certify to the employee's fitness to return to work.
